YOUR DIVIDEND

For the twenty-eighth consecutive year, we are sharing out the profit to our members as a dividend.

The Board will be recommending a **2% dividend** for approval at the AGM. Dividends are paid gross to your savings and are based on your average savings balance from October 2022 to September 2023. Withdrawing your savings can reduce the amount you earn.

Once agreed, the profit share will be credited to your account before the end of March 2024.

ANNUAL FEE

The Board will be presenting a motion to the AGM to charge an annual membership fee of ± 5.00 starting in October 2024 in line with Rule 17d which states:

Members have agreed to pay any annual administration fee of an amount not to exceed ± 5.00 , or any such reasonable amount sufficient to cover the administration costs of membership specified by the Board of Directors from time to time and agreed by the Members at the Annual General Meeting.

You need to attend the AGM to vote on the motion.
